PLEASE TAKE NOTICE THAT :

This section is in reference to MANDATORY JUDICIAL NOTICE OF THE LAW Section 1-3 and JUDICIAL NOTICE OF STIPULATION OF FACTS AND INTENT Section 4

1. FACT: "A person may be naturalized as a citizen of the United States in the manner and under the conditions prescribed in this title and **not otherwise**¹;
2. FACT: The above referenced act is **THE ONLY** procedure a person may be naturalized;
3. FACT: Brenda and Russ's families have been identified and registered²;

5. FACT: i, Brenda, nor Russ nor our posterity have any documentation of:
 - a. Nationalization;
 - b. renunciation of previous personal status to become a citizen of the occupying power;
 - c. green cards;
 - d. any type of residency card;
 - e. have a visa;
2. FACT: Brenda, Russ and their posterity's cannot be naturalized due to the lack of documentary evidence of alien enemies status;
 - a. If i/we are mistaken, please provide the documentary evidence for inspecting and verification of authenticity immediately to clear up any miscommunication and misunderstanding³;
3. FACT: It is prohibited under the laws of war⁴ to force me to swear allegiance⁵ to any hostile power or force me to become one of its citizens;
4. FACT: i, [Brenda] gave my oath of allegiance to the Constitution of the United States and the Union of States⁶ thereunder which is the foundational and governing bilateral contract⁷;

I declare under penalty of perjury under the laws of the United States of America, and we will appear mind, body, and soul, to verify that the foregoing is true and correct.

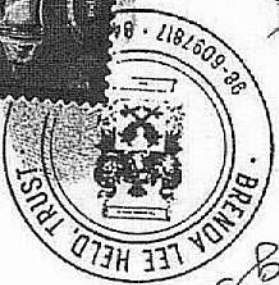
