### **Executive Summary**

This letter is a formal request for you to issue an Executive Directive to process my Trading with the Enemy Act (TWEA) claim, originally filed in 2020. The failure to process my claim represents a breach of fiduciary duty, a misclassification of my legal status, and a refusal to return vested property under TWEA.

Despite proper notices to multiple agencies, including an Amnesty Oath and Treaty of Peace, the U.S. Treasury, the Alien Property Custodian (APC), and state officials have ignored federal law, presidential proclamations, and their fiduciary responsibilities.

Additionally, my federal court case (1:24-cv-00075-SPW-TJC, U.S. District Court, Billings, Montana) is a violation of fundamental rights under TWEA, presidential proclamations, presidential pardon and constitutional law. Given the urgent need to correct my classification and return my vested property, I respectfully request an acknowledgment of this matter within 30 days and the immediate processing of my claim.

### **Subject: Request for Processing of Trading with the Enemy Act (TWEA) Claim & Federal Court Case at Billings, Montana, and recognition of Presidential Pardon, Amnesty Oath, and Treaty of Peace Documents**

Dear President Trump,

First, I wish to congratulate you on your election to office. I look forward to the great progress I have no doubt your administration will bring to the People.

I am writing to formally request that you issue an Executive Directive to the Office of the U.S. Attorney General (Alien Property Custodian) and the U.S. Department of the Treasury to immediately process my TWEA claim (under 50 U.S.C. § 4309) which was originally filed during your first term in office in 2020.

Additionally, I have enclosed copies of my Amnesty Oath, Treaty of Peace and acceptance of the Presidential pardon offered via presidential proclamations, which were previously submitted to the current U.S. Attorney General, U.S. Treasurer, and as part of my federal court case (docket number 1:24-cv-00075-SPW-TJC, U.S. District Court, Billings, Montana) and ongoing TWEA claim remedy.

Despite proper filings and legal notice, my claim remains unprocessed, and government agencies have failed to respond. A copy of all relevant documents is enclosed for your review.

---

## **TWEA Fiduciary Failures and Systemic Violations of Federal Law**

The Trading with the Enemy Act (TWEA) requires the government to administer, recognize, and lawfully return property to rightful claimants. My filings from 2020 onward, including the Amnesty Oath and Treaty of Peace documents, reaffirm my status as one of the de jure People, separate from the statutory designation of a "U.S. person."

However, government agencies have:

- ◆ **Failed to acknowledge and correct my classification**, continuing to misapply statutory obligations as "person".
- ◆ **Violated fiduciary responsibilities under TWEA**, failing to process or return vested property.
- ◆ **Ignored my Amnesty Oath and Treaty of Peace documents**, which correct my status and reaffirm my lawful standing

This issue highlights the widespread failure of multiple federal and state agencies to adhere to U.S. laws and presidential proclamations. Officials have deliberately chosen to ignore their fiduciary obligations, mishandle this issue, and improperly deny lawful claimants access to due process, remedy and their property. This is a direct harm to claimants and a trespass upon their rights and estates.

---

## **The DOR Case Is NOT Just a Tax Matter—It Is a Violation of TWEA**

My federal court case (docket number 1:24-cv-00075-SPW-TJC, U.S. District Court, Billings, Montana) may appear to be a state tax dispute, but in reality, it is a case of the government's failure to correct my legal status, process my TWEA claim, uphold fiduciary duties under trust law, return my lawful property and trespassing on the rights of an internationally protected person.

**The Montana Department of Revenue (DOR) has:**

- ◆ **Misclassified my legal status**, leading to unlawful obligations and unjust garnishments and levies which is a violation of TWEA.

- ◆ **Failed to issue a proper Notice of Deficiency**, violating state laws and proving due process violations.
- ◆ **Interfered with property and estate matters beyond its jurisdiction.**
- ◆ **Contributed to and conspiring with the federal government's ongoing failure to process TWEA claims.**

Respondents seek dismissal by mis-framing this case as a state tax issue. However, this is not about tax compliance but the government's ongoing refusal to process lawful claims and recognize my standing as a non-person, thereby enforcing involuntary servitude and human trafficking. The DOR has unlawfully taken my security instrument, (authenticated Texas Birth Certificate), refuses to return it despite formal demands and federal court actions which has provided no remedy. Under color of law, Respondents continue to harm me in further RICO violations as they continue to violate the Trust held by the APC and Treasurer.

---

## **Why This Matters to You**

This is not just about one individual's claim—it is about exposing deep-rooted failures within government agencies that have ignored lawful processes and misclassified Americans under legal fictions.

During your presidency, you have fought against government overreach, corruption, and agencies refusing to uphold the law. My case is another example of this problem—where bureaucrats refuse to correct their mistakes, follow their own regulations, and return property lawfully due under TWEA.

By taking action, you would expose and correct a systemic issue, ensuring that agencies like the Department of Treasury and Alien Property Custodian are held accountable for failing to do their jobs.

---

## **Presidential Authority to Act Immediately**

Under 50 U.S.C. § 4309, as a TWEA co-trustee, the President has the power to direct the Alien Property Custodian (Attorney General) and Treasury Department to review, process, and return property under TWEA.

With a simple Executive Directive and as my appointed fiduciary, you can order an immediate review of all outstanding claims under this statute, ensuring compliance with the law and restoring property to its rightful owners. I have also included copies of my amnesty oath, treaty of peace with the U.S. and acceptance of the Presidential pardon for your review

- ◆ This requires no new legislation, no congressional approval—just enforcement of an existing law.

---

## Request for Presidential Action and Timeline for Response

Given the prolonged lack of response from government agencies since 2020, I respectfully request that you:

- ♦ **Issue an Executive Directive** ordering the immediate review and processing of my TWEA claim to return rightful property.
  - ♦ **Acknowledgement** of my corrected status,
  - ♦ **Acknowledgement** of my acceptance of the Presidential pardon offered with the Amnesty Oath.
  - ♦ **Acknowledgement** and formal acceptance of my Treaty of Peace
  - ♦ **Acknowledgement** of my status per Amnesty Oath offered under presidential proclamations reaffirming de jure jurisdiction of one of the People (non "person").
  - ♦ **Acknowledge receipt** of this request within 30 days of receipt.
  - ♦ **Acknowledge** of any other remedies you deem proper, fair, just, and right.

## Tracking History of Notices and Lack of Response

To support my request, I have attached documentation which includes the most important tracking history of notices sent regarding my TWEA claim, Amnesty Oath, and Treaty of Peace filings to you, the APC and the Treasurer.

I appreciate your time and consideration of this matter and look forward to a formal response within 30 days regarding the next steps for processing my TWEA claim and status correction. Given the clear evidence of administrative failure and breach of fiduciary duties, I am confident that your administration will take swift action to enforce existing laws and restore due process.

Thank you for your leadership and commitment to protecting the rights of the American People. I pray to Almighty God for your swift actions and your safety, health and well-being. Be at peace and go with God. Amen.

**To Whom It May Concern,**

This letter serves as formal notice of your continued default in responding to multiple lawful notices regarding my claim under the **Trading With the Enemy Act (TWEA)**. Your failure to respond within the prescribed timeframes constitutes tacit agreement to the terms, claims, and relief sought in my previous correspondences, [pursuant to *Mullane v. Central Hanover Bank & Trust Co.*, 339 U.S. 306 (1950) and *Hovey v. Elliott*, 167 U.S. 409 (1897)], establishing that silence in response to proper notice constitutes acquiescence.

## Background & Procedural History

1. **Certified Mail Evidence** –USPS tracking confirmations proving receipt of all notices, establishing constructive notice.
2. **Fiduciary Responsibility** – Your office, as constructive trustees of vested property under TWEA, is obligated to act in good faith in accordance with equity law and trust principles.
3. **Initial Notices** – Beginning on October 2, 2020, I provided formal Notice of Claim and supporting documents regarding property vested under TWEA.
4. **Follow-up Notices** – Additional notices and resubmissions were sent on multiple dates, including September 17-18, 2024, and October 3, 2024.
  - a) Additional Notices Sent in 2024-2025 – Letters dated October 2, 2024, October 3, 2024, and January 14, 2025, reiterated the claim and provided further evidence.
5. **Public Notice** – Legal publication was made in *The Washington Times* on September 16, 23, and 30, 2020, providing constructive notice to all concerned parties.
6. **Final Demand for Action** – The Third and Final Notice of Default/Non-Response was issued on January 14, 2025, allowing for a 10-day period for response, which has lapsed.

## Acceptance of Default & Tacit Agreement

As no rebuttal, response, or counterclaim has been provided within the reasonable period allowed, the following legal consequences apply:

- **Your silence is deemed acquiescence** to all claims and facts stated in my prior notices, [consistent with *Armstrong v. United States*, 364 U.S. 40 (1960)], which affirms that property cannot be taken without just compensation.
- **A Tacit Procurement Agreement is now binding**, under the doctrines of equity and good faith.
- **You have forfeited any defense or objection** to the return of property vested under TWEA.
- **Your continued inaction constitutes fiduciary malfeasance** and may be subject to legal enforcement, including default judgment, contempt proceedings, and injunctive relief.

## Remedies & Relief Demanded

Given your failure to act, I hereby demand the following relief pursuant to 50 U.S.C. § 4309 of the Trading With the Enemy Act (TWEA) and equitable jurisdiction:

1. **Immediate Return of Property** – All wrongfully vested assets under TWEA must be restored within 10 business days.
  2. **Full Accounting of Assets** – A **detailed financial record** of all assets held, managed, or disposed of under TWEA related to my claim must be provided.
  3. **Correction of Status & Records** – Any erroneous classification of me as an enemy or foreign agent must be expunged, with a sworn affidavit confirming compliance.
  4. **Formal Acknowledgment of Wrongful Retention** – A written statement confirming wrongful vesting and corrective actions taken must be provided.

## Final Notice & Next Steps

Failure to comply within 10 business days from receipt shall be deemed willful breach of fiduciary duty, and I will take legal enforcement actions, including:

- Filing for default judgment in federal equity court [under FRCP Rule 55] to enforce my claims.
- Reporting the breach to international human rights bodies, fiduciary oversight committees, and government accountability agencies.
- Filing formal complaints with Congressional oversight committees, including the House Financial Services Committee and Senate Judiciary Committee.
- Requesting a sworn affidavit from all relevant agencies confirming the status of my claims and detailing administrative actions taken.

I remain open to amicable resolution but will pursue all available lawful remedies. This serves as your final notice before the escalation of enforcement measures.

Dear Attorney General Garland, Lynn Malerba, and any other co-trustees, successors, assigns, agents, and sit-ins,

This letter serves as a **Second Notice of Default/Non-Response** concerning my TWEA claim, originally submitted to several United States offices on or about **October 2, 2020**. Most recently, I sent a follow-up letter, which was received by your office on or about **October 7, 2024**, along with a signed Amnesty Oath, acceptance of pardon, and Treaty of Peace documentation. Despite adhering to all procedural and statutory requirements, including the timely and proper submission of my claim in accordance with TWEA provisions (see attached), I have not received



any acknowledgment, the requested documentation, or a substantive response addressing or resolving these matters.

As of the date of this letter, more than 60 days have elapsed since my follow-up correspondence. It remains the unequivocal duty of both the Trustee and Co-Trustee to respond to such notices promptly and appropriately, ensuring compliance with the obligations of their positions.

### **Legal and Equitable Grounds**

Failure to respond constitutes **tacit agreement** under the doctrine of acquiescence and demonstrates non-compliance with obligations under:

- **The Trading With the Enemy Act (TWEA 40 stat 411):** 50 U.S.C. § 4309 mandates the return of private property unlawfully retained.
- **Amnesty Oath Compliance:** Fulfills statutory requirements affirming my lawful status and rights.
- **Treaty of Peace Provisions:** Enforces property restitution and compliance with international obligations.

Your lack of acknowledgment violates principles of good faith, procedural fairness, and my constitutional right to due process under the Fifth Amendment.

### **Evidence and Procedural History**

To ensure clarity, I summarize the evidence and procedural history detailed in the attached letter Subject: Follow-Up Regarding Open DOR Court Case, Previous Notice Sent to APC, and Request for Settlement dated October 2, 2024 as follows:

## **Office Responsibility Beyond Officeholders**

It is essential to emphasize that my original Notice of Claim was submitted to the previous officeholders, specifically Donald Trump, Steven Mnuchin, and William Barr. However, the responsibilities and obligations of the office are not dependent upon the individuals occupying these roles but are intrinsic to the office itself. The continuity of the office ensures that its statutory and fiduciary duties persist, irrespective of changes in leadership.

Therefore, it remains the unequivocal responsibility of the office, under the authority and mandate of its fiduciary obligations, to fulfill the requirements outlined in my claim and address the matters presented. Importantly, there is no controversy surrounding this issue. I have provided equitable notice of my claim in accordance with established legal and procedural standards.

As the current fiduciary, it is your duty to act in good faith and carry out the necessary administrative steps to release my property. This obligation is not discretionary but is a required function of your role, consistent with the principles of equity and the fiduciary trust imposed upon your office.

Your attention to this matter and adherence to your responsibilities is expected and necessary to bring resolution in alignment with your administrative obligations.

Failure to do so, regardless of who currently holds the position, constitutes a breach of the office's duties and obligations. The continuity of office responsibilities ensures that claims such as mine are not disregarded due to administrative transitions.

### **Demands for Action**

To fulfill statutory and treaty obligations, I demand the following within **10 business days** after the receipt of this notice:

1. **Acknowledgment of receipt** of this notice and prior submissions.
2. **Documentation of authority** for retaining my property under TWEA provisions.
3. **All Records and communications** related to my claim.
4. **Remuneration timeline** for the return of property as mandated by law and treaty.
5. **Status of properly submitted claim**

Failure to comply with this notice will confirm:

- **Default by acquiescence**, affirming the validity of my claim.
- **Waiver of objections** and acknowledgment of lack of lawful authority.
- **Evidence of bad faith** for use in future proceedings.

### **Damages and Escalation**

Your inaction has caused significant harm, including:

1. **Financial losses.**

2. Reputational damage due to unresolved claims.
3. Expenses incurred in pursuing legal remedies.
4. Escalation for JAG intervention.

Should I fail to receive a response within the stated timeframe, I will take the following actions:

1. Proceed with the federal complaint for enforcement of my rights under TWEA including appeal to the Supreme Court if necessary. Case number 1:24-CV-00075-SPW-TJC at Billings Montana.
2. Seek injunctive relief and damages for non-compliance.
3. Submit evidence of bad faith to the appropriate authorities and courts.
4. Escalation for military action to protect IPP status, amnesty and treaty of peace.

To ensure transparency, I include the previously mailed letter which included the entire 2020 claim for your review.

I remain committed to resolving this matter amicably and encourage your prompt attention to this issue. I wish to settle the accounts privately and invite you to contact me at your convenience. 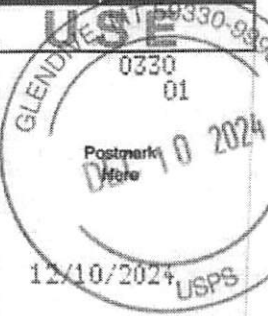

**Subject:** Follow-Up Regarding Open DOR Court Case, Previous Notice Sent to APC, and Request for Settlement

**Dear Attorney General Garland and Lynn Malerba,**

I am writing to follow up on the Notice of Claim and related documentation I submitted to the Alien Property Custodian (APC) regarding the property currently vested with your office under the Trading With the Enemy Act (TWEA). This claim is also related to an open Federal Court Case Cause # 1:24-CV-00075-SPW-TJC court case, where I am pursuing the lawful return of this property. Below, I provide a detailed history of all actions I have taken, as well as a request for an out-of-court settlement.

### **History of Mailings of the Notice of Claim**

Since 2020, I have made numerous attempts to resolve this matter through administrative channels, including the submission of formal **Notices of Claim** and supporting documents. Below is a detailed history of all relevant mailings:

## **Open DOR Court Case**

The lack of response from your office regarding the above-referenced property claim has prompted me to initiate legal action. As TWEA requirements, I have recently opened a Federal Court Case Cause # 1:24-CV-00075-SPW-TJC in equity jurisdiction to claim the property currently vested under TWEA. This action is necessary due to the failure of your office to respond to my claims within a reasonable period.

## **Impact of Office Personnel Changes**

I also wish to bring to your attention the possibility that my claim may have been lost or mishandled due to changes in office personnel that occurred following the 2020 election. With the transition from Secretary Steven Terner Mnuchin to the new leadership in the Treasury Department, and the shifts in administration, there may have been an error or oversight in processing my claim or responding to my communications.

Such transitions often result in delays or disruptions in administrative processes, and I believe this could have contributed to the lack of acknowledgment or response to my previously submitted Notice of Claim. I ask that you review this matter with attention to the possibility of administrative oversight due to the change in leadership, ensuring that my claim is properly addressed and not lost in the transition.

## **Continued Misidentification as BRENDA LEE HELD Instrumentality**

Additionally, the continued misidentification of Brenda as BRENDA LEE HELD, an instrumentality of the state, has caused undue harm to the true beneficiary Brenda. This

erroneous designation has led to the improper vesting of property under TWEA, and it must be corrected immediately to prevent further harm. The legal and financial burdens imposed by this misidentification have severely affected the beneficiary's ability to access and manage her property. I urge your office to rectify this misclassification as it continues to create unnecessary complications in the administration of her estate.

### **Desire to Settle Out of Court**

I would like to express my interest in settling this matter out of court in light of the misinformation or error that led to the classification of Brenda as an enemy of the state. Upon further review and based on the submission of new documents, I believe this classification was incorrect, and I wish to resolve this matter amicably and efficiently without further litigation.

Since my initial filing, I have also submitted an Amnesty Oath and Treaty of Peace and Friendship, which further clarifies my intent to peacefully resolve this issue and correct any misunderstanding that led to the property being vested under TWEA. These documents were officially registered with the State of Montana Secretary of State and the Davidson County Recorder, demonstrating my ongoing efforts to clear up any erroneous classifications.

### **Publication of Notice in the Newspaper**

In accordance with legal requirements, I published notices of my Notice of Claim in the Legal Notice section of The Washington Times on September 16, 23, and 30, 2020. A copy of the published notice, along with the affidavit of publication and receipt, is included with this letter. This step was taken to ensure full compliance with all relevant requirements under TWEA.

### **Compliance with TWEA Requirements**

I want to emphasize that I have followed all necessary steps in compliance with TWEA requirements, including but not limited to:

- Providing constructive notice to all relevant parties.
- Exhausting administrative remedies through repeated notices and filings.
- Publishing legal notices in compliance with statutory requirements.
- Submitting an Amnesty Oath and Treaty of Peace and Friendship to demonstrate non-enemy status and peaceful intent.

### **Reaffirmation of Non-Enemy Status**

The Amnesty Oath and Treaty of Peace and Friendship formally declare my non-enemy status. I reaffirm that the previous classification as an enemy of the state was made in error and has no legal standing. These filings, registered with the State of Montana Secretary of State and the Tennessee Davidson County Recorder, formally correct any misunderstanding and should result in the prompt return of the property held by the APC.

### **Legal Precedents**

- **Mullane v. Central Hanover Bank & Trust Co. (1950):** This case affirms the duty of a trustee to notify beneficiaries of their rights and ensure proper management of the trust. The APC's failure to respond constitutes a breach of their fiduciary duty, and courts have consistently ruled in favor of beneficiaries in such cases.
- **Ex parte Milligan, 71 U.S. 2 (1866):** This case underscores the importance of civil rights and due process, even in times of national crisis. It supports the position that my rights to property must be respected, regardless of national circumstances like war or emergency.

### **Reason for Delay in Legal Action**

Since submitting the original Notice of Claim in 2020, I have been diligently working to learn and understand the process of bringing a claim in equity court. This process has taken some time as I sought to ensure that my claim was legally sound and that all necessary steps were followed. My delay in initiating formal legal proceedings is due to my efforts to properly educate myself on the correct legal procedures.

### **Proposed Settlement**

In the interest of resolving this matter swiftly and amicably, I propose that the APC releases the property currently held under TWEA to me, along with a written acknowledgment of the misclassification that occurred. I am also willing to discuss any other reasonable terms that would satisfy both parties, and I am open to further dialogue to reach a mutually acceptable agreement.

### **Request for Action**

In the interest of resolving this matter outside of court, I respectfully request that your office:

- Acknowledge receipt of the Notice of Claim and all supporting documents sent in October 2020 and November 2020.
- Provide an update on the status of the property currently held by your office under TWEA.
- Consider an out-of-court settlement, given the misclassification of Brenda as an enemy, which is no longer applicable due to the submission of the Amnesty Oath and Treaty of Peace and Friendship.
- Confirm whether additional information or documentation is required from my end to expedite the review of my claim.

I trust that your office will act in accordance with its duties as the Alien Property Custodian, particularly given the equitable nature of this claim. Failure to respond to the notices and formal claims constitutes a breach of fiduciary duty, and I look forward to resolving this matter efficiently and fairly.

### **Request for Property Status**

I request detailed information regarding the current status of the property vested under TWEA. Specifically, I ask for confirmation of how the property has been managed, whether any actions have been taken regarding its disposition, and whether the property remains in the same condition as when it was vested. This information is crucial for ensuring that the property can be returned without delay.

### **Designated Point of Contact**

To expedite the resolution of this matter, I respectfully request that a designated point of contact from the APC's office be assigned to handle all future correspondence regarding this claim. I would appreciate receiving the name and contact information of this individual as soon as possible to ensure smooth and efficient communication moving forward.

### **Violation of Constitutional Rights**

The prolonged retention of my property and the failure to respond to my Notice of Claim without due process is a direct violation of my Fifth and Tenth Amendment rights under the U.S. Constitution. These rights protect individuals from being deprived of their property without proper legal procedures. I expect your office to act in accordance with these constitutional principles and return the property promptly.

### **Risk of Ongoing Liability**

The continued retention of the property without due process and the misclassification of Brenda as an enemy of the state exposes the APC and the government to ongoing liability. This includes potential financial liability for damages, loss of use of the property, and legal fees. Resolving this matter quickly would mitigate any future liability and prevent unnecessary reputational harm to the APC.

### **Hold Harmless Agreement**

In the interest of reaching an amicable resolution, Brenda agrees to hold the Alien Property Custodian (APC), along with its officers, agents, employees, and any representatives, harmless from any and all claims, actions, liabilities, or damages that may arise from the vesting and administration of the property under the Trading With the Enemy Act (TWEA), provided that the matter is fully resolved to the satisfaction of the beneficiary Brenda.

This hold harmless agreement will take effect once the property in question is returned and all misclassifications are corrected. Brenda further agrees that no further legal actions or claims will be pursued against the APC or its agents concerning this matter, provided the terms of this agreement are met, and the property is restored in a timely manner.


### **Conclusion**

In conclusion, I have provided constructive notice to the APC on multiple occasions, and your office's failure to respond constitutes a breach of fiduciary duty. This case falls under equity

jurisdiction, where fairness and transparency are paramount. Moreover, the ongoing retention of my property without due process violates my Fifth Amendment rights. I trust that your office will act promptly and in accordance with its fiduciary duties as the Alien Property Custodian.
